LEGAL BASIS FOR THE PROCESSING

The personal data indicated on this page are processed by the Data Controller following the free consent provided by the user ("involved in the processing") to the Data Controller. The optional, explicit and voluntary sending of electronic mail to the address indicated on this site and the completion of electronic forms to forward requests aimed at using the services offered or proposed initiatives to receive promotions, advertising material, estimates of expenditure and possible provision of services, involves the acquisition of the address of the sender, as well as any other personal data included in the message and/or in the electronic form.

TYPES OF DATA PROCESSED AND PURPOSE OF THE PROCESSING

Navigation data

The computer systems and software procedures used to operate this site acquire, during their normal operation, some personal data the transmission of which is implicit in the use of Internet communication protocols.

This category of data includes IP addresses or domain names of computers and terminals used by users, addresses in URI/URL notation (Uniform Resource Identifier/Locator) of the requested resources, the time of the request, the method used in submitting the request to the server, the file size obtained in response, the numerical code indicating the status of the response given by the server (success, error, etc.) and other parameters related to the operating system and the user's computer environment.

Data communicated by the user

The optional, explicit and voluntary sending of messages to the company's contact addresses, as well as the completion and submission of the forms on the site, entail the acquisition of the sender's contact data, necessary to respond to the requests of the user, as well as all personal data included in the communications.

Cookies and other tracking systems

(What are cookies?)

Cookies are small text files exchanged between a website and the user's navigation browser, each time the internet site is accessed. They are used to perform automatic authentication, to keep track of sessions, to store information to improve the browsing of the site or the user's browsing experience. Each domain visited through a browser can set one or more cookies. DATA RETENTION
